[1] WeLab Bank GoWealth x GoSave Promotion (the "**Promotion**") shall start from 13 November 2023 until 3:00 pm Hong Kong Time on 30 November 2023 (both dates inclusive)(the "**Promotion Period**") or unless otherwise specified.

[2] The Promotion is only applicable to selected customers who hold or have opened (as the case may be) a valid Investment Account with WeLab Bank Limited ("**WeLab Bank**", "**we**", "**us**" or "**our**") and receive relevant Promotion notification emails, phone calls and/or in-app notification from us within the Promotion Period ("**you**", "**your**" or "**Selected Customers**").
