

Third Round of "Win HKD10,000 Prize Every Week" Lucky Draw – Terms and Conditions

- 2. By participating in this Campaign, you acknowledge that you have read and agreed to these Terms and Conditions.
- 3. This Campaign is only applicable to WeLab Bank's customer who:
 - I. maintains a valid WeLab Bank Core Account as of the day immediately before the Lucky Draw Date as stated in Clause 7;
 - II. places at least one designated GoSave 2.0 Time Deposit during the Campaign Period;
 - III. is not the employee of WeLab Bank or any of its affiliated companies (the "Eligible Customer").
- 4. If the Eligible Customer is found to have violated these Terms and Conditions, tampered with the process of the Campaign, jeopardized the fairness of the Campaign, engaged in any illegal, fraudulent, abusive, or dishonest behavior, made false statements, or violated applicable laws or regulations, The Bank has reserves the right to disqualify the participant without prior notice and may seek compensation for any associated damages or losses.

The Winner will be notified by email and phone call (the "Winner Notification") within 2 business days from the Lucky Draw Date according to his/her latest email address and the mobile phone number registered with the Bank. The redemption method of the Prize or Substitute Prize (if applicable) will be included in the Winner Notification. The Winner must follow the redemption details in the Winner Notification to redeem the Prize or Substitute Prize (if applicable). We will also announce the Winner on our official website and WeChat Official Account "汇立银行 WeLab Bank".
- 10. During the Campaign Period, you agree and acknowledge that you are not entitled to the Prize or Substitute Prize (if applicable) if you (i) become an employee of the WeLab Bank or its affiliates, or (ii) close your Core Account and/or terminate the designated GoSave 2.0 Time Deposit before redemption of the Prize or Substitute Prize (if applicable).



- 11. WeLab Bank reserves the right to draw another Winner to replace any Winner who is or may be subsequently found to be ineligible or disqualified to the Lucky Draw.

- 26. The Lucky Draw is held within Hong Kong Special Administrative Region. These terms and conditions shall be governed by and construed in accordance with the laws of Hong Kong and each Eligible Customer submits to the exclusive jurisdiction of the courts of Hong Kong.
- 27. These terms and conditions shall be read in connection with our Account Terms and GoSave 2.0 Time Deposit Terms and Conditions. Terms defined in our Account Terms or GoSave 2.0 Time Deposit Terms and Conditions shall have the same meanings when used herein, unless otherwise defined. In the event of inconsistency between these terms and conditions, the Account Terms and GoSave 2.0 Time Deposit Terms and Conditions, the prevailing order shall be as follows:
 - I. these terms and conditions; and
 - II. the GoSave 2.0 Time Deposit Terms and Conditions; and
 - III. the Account Terms.
- 28. If there is any inconsistency or conflict between the English and Chinese version, the English version shall prevail.
