### Example 2:

Assuming a customer has subscribed Fund B for HKD 5,000 and Fund C for HKD 10,000 and maintained such positions before Promotion Period and has performed the following transactions during the Promotion Period:

The eligible fund position is maintained until the end of the Maintenance Period. ### Example 3:

Fund B is partially redeemed. Accumulated Eligible Transaction amount is HKD 50,000 and hold till the end of 28 June 2024, hence, the customer can enjoy a one month 3.8% Cash Reward of HKD 156.2 =HKD 50,000\*3.8%\*30/365 on or before 19 July 2024.

### Example 4:

Fund B is partially redeemed during the campaign period. Accumulated Eligible Transaction amount is HKD 190,000 and hold till the end of 28 June 2024, hence, the customer can enjoy a one month 13.14% Cash Reward of HKD2,052 =HKD 190,000\*13.14%\*30/365 on or before 19 July 2024.

### Example 5:

Assuming a customer does not hold any fund position before Promotion Period and has performed the following transactions during the Promotion Period:
